School Medication Administration Procedures

It is the policy of the Burlington Area School District, that all student medications, both prescription and non-prescription, will be administered in accordance with state law. Therein, any medication must be recognized as drugs in the official U.S. Pharmacopoeia and national formulary or official Homeopathic Pharmacopoeia of the United States or any supplemental publication to these references. Personnel of the Burlington Area School District under the direction of a Registered Nurse, will administer all medications. Students of the Burlington Area School District are NOT allowed to carry and self-administer ANY medication while attending school with the exceptions of: Inhalers, Insulin, Epi-Pens & Glucagon. All medications are to be brought to school by the parent / guardian and must meet the following requirements:

Prescription Medications:

- 1. All prescription medications including inhalers & Epi-Pens require a Medication Administration Consent Form signed by the prescribing MD / PA / NP and parent. These forms are available for download on the school website and from the school health office. Parents will have up to 48 hours to submit completed official authorization to the school.
- 2. Prescription medications will be administered according to MD orders by designated school personnel under the direction of a registered nurse
- All medications (over the counter & prescription) given at school must be in the original container with:
 - Student's full name on the container
 - Medication name on the container

If prescription:

- a. Pharmacy name & phone number
- b. Prescription number
- c. Physician name
- d. Dosage and Instructions
- 4. Narcotic pain medications will **not be administered** by the health services department personnel. It is in students best interest to remain at home while taking this type of medication.
- 5. A physician order is required for any prescription medication dose changes. Only a registered nurse can take verbal medication orders.
- 6. Morning medication doses should be administered to the student at home **PRIOR** to school arrival to prevent the transporting of potential controlled-substances between home & school and to assure the medication is benefitting the student prior to 1st hour classes.
- 7. The first dose of a newly prescribed medication should not be administered at school.

Non-Prescription Medications (Over-the-Counter):

- 1. All non-prescription medications require a Medication Administration Consent Form signed by the parent / guardian. Parent will provide the school with the supply of medication in the original bottle.
- 2. The student's supply of non-prescription medication such as Tylenol, Ibuprofen, etc..., will be kept at school in the health room for occasional use by the student throughout the school year and will be administered by appropriate personnel according to policy.
- 3. Non-prescription medication will only be administered per label instructions. Written orders are needed from a licensed prescriber for administration in a dosage other than the recommended dose.

All Medications:

- All medications must be brought to school by the parent/guardian. No medication should be sent to school with a student.
- All medications must be in the original container. No baggies of medication will be allowed.
- All medication will be kept in a locked container or cabinet in the health room. Designated school personnel will supervise the student while taking the medication. Self-administered medications (inhalers, Epi-Pens, insulin) are an exception to this and require specific consent.
- A medication record will be kept for each student receiving any medication (prescription or non-prescription), at school with the exception of self-administered medications.
- Parents must notify the school when a medication is discontinued.
- New medication administration forms must be received at the start of each school year for any medication.
- NO medications will be sent home with a student. Medications can only be picked-up by the parent / guardian.
- All medications will be disposed of according to health safety guidelines, 2 days after the conclusion of the last day of school.
- Emergency medication (epinephrine auto-injector) not prescribed to a specific individual will be available and accessible for use to treat a life-threatening allergic reaction. School personnel may assume parent consent is given for emergency medications.

- Medication errors will be documented on a Medication Incident Report Form and the following individuals will be notified immediately:
 - 1. School Nurse
 - 2. Parent / Guardian of Student
 - 3. School Administrator
 - 4. Student's Physician

Complementary & Alternative Medication (CAM):

The National Center for Complementary and Alternative Medicine (NCCAM) defines this category as a "group of diverse medical and health care systems, practices, and products that are not generally considered part of conventional medicine." (NCCAM, 2011).

In accordance with state law and Burlington Area School District policy, all non-prescription and prescription medication must be recognized in the official U.S. Pharmacopeia and national formulary or official Homeopathic Pharmacopoeia of the United States.

For the safety and protection of students, complementary and alternative medications, preparations and/or solutions, which are intended to create a change in health status, will not be given in the school setting unless approved by the FDA or prescribed by a practitioner (MD/PA/NP).

The following criteria must be met on the CAM prescription:

- Is presented in the original container with label
- Use for student is indicated
- Appropriate dosing for student is clearly stated on the label / packaging insert
- Possible untoward effects are listed
- Signed practitioner consent if non-FDA approved
- Signed parent/guardian statement

The Burlington Area School District reserves the right to refuse administration of a complementary and alternative medication, preparation and/or solution, even with a prescribing signature, in the event that the use of medication could create safety implications or change the baseline health status for other individuals within the school setting.

Extended or Overnight Field Trip Medication Use:

- 1. Medications taken during times outside of the normal school day during an extended or overnight field trip, are required to follow the guidelines of this policy. Extended or overnight trips require a seperate form.
- 2. Only necessary and required medications should be sent, with the exact number of pills that will be needed for the trip duration. Medication must be in the original container.
- 3. All medications will be carried by school personnel responsible for trip coordination. Students are not allowed to carry medications with them, with the exception of emergency medications (inhalers, epi-pens, diabetic medication).
