## Comments regarding progress made towards obtaining policy goals:

The BASD Director of School Health Services and Business Manager met several times during the 2019-2020 school year to review the District Wellness Policy. A meeting was held February 28<sup>th</sup>, 2020 which consisted of BASD Director of Health Services, BASD Business Manager, Advocate Aurora Community Outreach, BASD elementary teachers, parents of BASD, BASD Food Service Director and members of BASD PTO. The District Wellness Policy was reviewed during this meeting. BASD is in the process of updating all policies, including the Wellness Policy. Below is our WellSAT score: the state average comprehensiveness score is 45 and the state average strength score is 26. BASD exceeds the state average in both areas. BASD is committed to a strong, ongoing wellness program.

The Wellness School Assessment Tool (WellSAT) allows schools/districts to evaluate how their policy addresses 67 best practice policy items. WellSAT scores are calculated for comprehensiveness and strength. The comprehensiveness score reflects the extent to which recommended best practices are included in the policy. The strength score reflects how strongly the policy items are stated. Scores range from 0 to 100, with lower scores indicating less content and weaker language and higher scores indicating higher content and the use of specific and directive language.
