DETERMINATION AND CLASS RANK

The School Board is committed to providing an educational environment that result in student success and reflects high expectations.

It shall be the responsibility of the high school administrator or designee to determine grade point averages and class standings.

Beginning with the graduating class of 2016, the grading scale for high school courses will be as follows:

DETERMINATION AND CLASS RANK

Code No. R 345.1

The following grading system will be in place for all who entered high school prior to the fall of 2012. Grades for all high school courses, including those designated as Honors Courses, are assigned the following points: A+:4.33; A:4.00; A-:3.67; B+:3.33; B-:3.00; B-:2.67; C+:2.33; C:2.00; C-:1.67; IP (in progress): 0; NC (no credit):0 points; P (credit earned):0 points.

Modified grading scale: A+:3.33; A:3.00; A-:2.67; B+:2.33; B:2.00; B-:1.67; C+:1.33; C:1.00; C-:.67

- A The student displays an unusually high level of application of all skills and concepts and evidences excellence in the quality of a finished product.
- B The student demonstrates a basic mastery of all skills and concepts, and also applies them to new and complex situations.
- C The student shows comprehension and a basic application of all skills and concepts.
- IP IN PROGRESS: This grade will be given only at the discretion of the instructor. An IP indicates that a student has course requirements to finish in order to receive a grade. The deadline for completing course requirements is two weeks beyond the grading period, at which point an A, B, C, NC will be given. (The end of the year time may vary, by department).
- NC NO CREDIT: The student rarely or never attempts or meets course requirements. A grade of NC could result in the student retaking the whole course or completing course requirements on a contract basis.
- P PASS: The student has satisfactory completed an alternative course used to meet the graduation requirements.

To determine the average, the sum of all of the grade points are divided by the number of approved academic courses attempted and completed regardless of grade points. Courses which meet less than five full periods per week shall not be used to calculate grade point averages for class standing.
