

Four requirements of DPI Corrective Action Case No. 20-PDA-02

- 1. Prevent further instances of discrimination in discipline
- 2. Adequately redress the racially hostile environment present in BASD
- 3. <u>Complete</u>: Review its past reporting on discrimination complaints to ensure compliance with BASD policies and procedures and enact clear guidelines for future reporting; and
- 4. <u>Complete</u>: Review its policies and procedures to ensure they comply with the Wisconsin Administrative Code.
